





Gel creates a protective layer on the nasal mucosa that mechanically blocks the entry of viruses into cells, thus protecting against infection and transmission of viruses to healthy people. In the event of an infection, the spray blocks the multiplication of viruses, thus alleviating the symptoms of the disease and shortening its duration.

Products are indicated for adjunctive use in the treatment of rhinitis, paranasal sinuses or allergic rhinitis (nasal only). The package contains 20 ml of gel, which translates into approximately 200 doses.



Active Ingredients

The main active ingredient is the sodium salt of hyaluronic acid, which has moisturizing and bioadhesive properties.

Mechanism of Action

Hyaluronic acid forms a protective layer on the surface of mucous membranes, providing moisture, protection from external factors, and supporting natural healing and regeneration processes. This protective layer also limits pathogen colonization and reduces the risk of bacterial infections.

Benefits

Regular use of Hyaluronic Acid Suppositories provides relief from hemorrhoids, itching, burning, and pain in the anal area, accelerates wound healing, improves tissue hydration, which is particularly important for older individuals, and reduces as well the risk of developing hemorrhoids and other inflammatory conditions.

Indications: during chemotherapy, radiotherapy or a combination of both therapies to alleviate and reduce symptoms of radiation proctitis/rectal inflammation;

- for the protection of the anal tissues in persistent constipation to reduce the sensation of friction during defecation, which protects against irritation and congestion in the anal area, providing relief;
- for physiological rectal lubrication in the elderly, which improves the normal function of the anus (sphincter);
- in adults at risk of developing haemorrhoids (overweight people, people with a sedentary lifestyle, laxative users, people who practice anal intercourse).

The protective layer alleviates irritation of the anal/rectal mucosa:

- for irritation in men undergoing transrectal prostate biopsy
- in case of irritation of the anus caused by environmental factors (underwear, hygiene products, etc.).
- for anal/rectal irritation after anal intercourse.

The protective layer acts as a lubricant and contributes to better functioning of the tissues supporting the rectum/rectum by improving the properties of the connective tissue. The genitourinary tract and the rectum/rectum are in close proximity and closely linked to the lifting muscle. Visceral discomfort is poorly localised and pelvic floor dysfunctions can impair urogenital and rectal function; indeed, these disorders have much in common and there is an overlap of symptoms. Therefore, a hydrating protective layer in the anus/rectum contributes to symptom relief:

- For chronic prostatitis (prostate, prostate), benign prostatic hyperplasia and interstitial cystitis, but also for bladder pain rectum/rectum.
- For symptoms of prostatitis such as pain occurring in the perineal area, mainly rectal/anal. The device can be used in combination with other therapies to treat both bacterial and non-bacterial prostatitis. The use of the device in this situation is a therapy aimed at relieving symptoms and providing a better quality of life. The device relieves symptoms associated with both chronic prostatitis and urinary symptoms. The direct action on the rectum/rectum and the effect of the protective layer of hyaluronic acid on perineal tenderness may facilitate an earlier therapeutic effect.


