# VirusPrevention Solutions

## Status:

## The nose:

the nasal mucosa forms the body's first physical barrier and the first line of defence of the immune system. Thanks to its special structure and mucus production, it clears the respiratory tract of inhaled harmful substances and prevents the entry and spread of viruses, bacteria and fungi. The air we breathe in through the nose is purified, hydrated and warmed, which is crucial for the work of the entire respiratory system.

## The mouth:

oral and pharyngeal mucosa is the body's physical protective barrier. A large number of different types of substances pass through the throat everyday. It is the entrance door to our body for nutrients, but also for microorganisms such as viruses. The specific structure of the oral and pharyngeal mucosa and the secretion of saliva prevents the entry and spread of viruses, bacteria and fungi.

## The Virus:

enters host cells and multiplies, leading to the onset of disease symptoms. Damaged nasal and oral mucosa and fails to perform its primary function and increases the risk of acute and chronic infectious diseases, including common seasonal viral infections of the nose or throat.

When the nasal or oral mucosa is damaged, infection with various types of viruses can occur, including coronaviruses including SARS-CoV-2 and influenza viruses that can cause influenza or the common cold, among others. Given the right conditions, the virus enters host cells and multiplies, leading to the onset of disease symptoms.

## We can protect ourselves against infection through daily prevention.

However the nasal and oral mucosa performs its protective function, but only when it is in good physiological condition, i.e. when it is well moisturized.

Too dry and overheated air, pollution particles, toxic fumes in the inhaled air and the topical use of nasal decongestants irritate the nasal mucosa and dry it out.

Elderly people are particularly vulnerable to viral and bacterial infections and are affected by dry nose, mouth and dry throat, which often causes damage to the nasal, oral and pharyngeal mucosa.

However, protection against infection can be promoted through daily prophylaxis.

The using of specialized products contributes to protection against the penetration and spread of viruses. It can help limit the penetration of viruses into the cells of the nasal and oral mucosa, which may consequently translate into reducing the possibility of developing viral infections of the upper respiratory tract caused by influenza viruses and coronaviruses, which can cause influenza or the common cold, among other things and contributes to protection against the spread of viruses, that is, to reduction of transmission from symptomatic or symptomatic infected individuals to others.

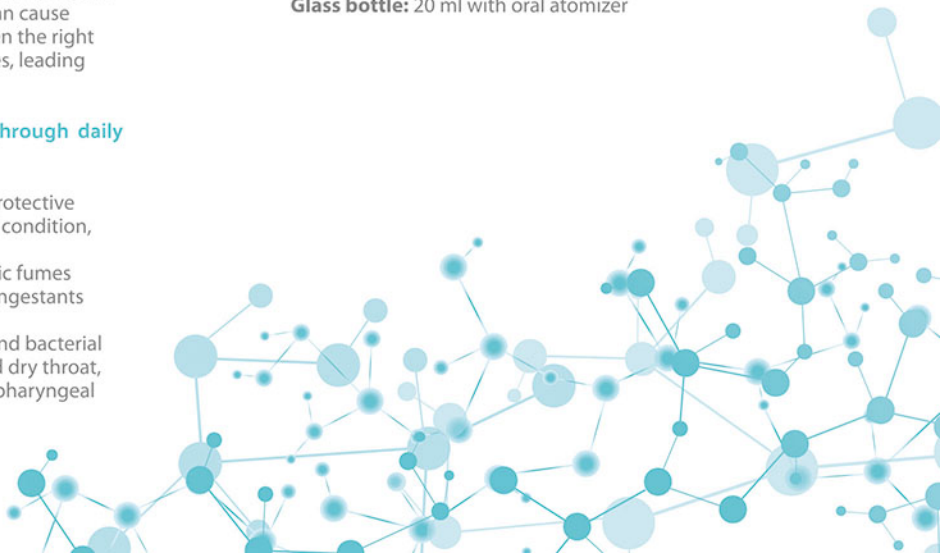

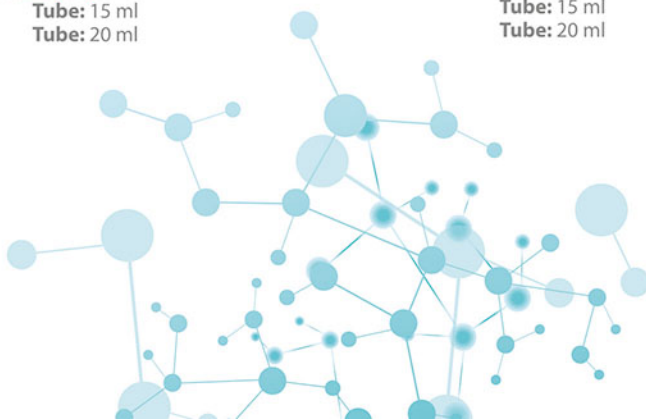

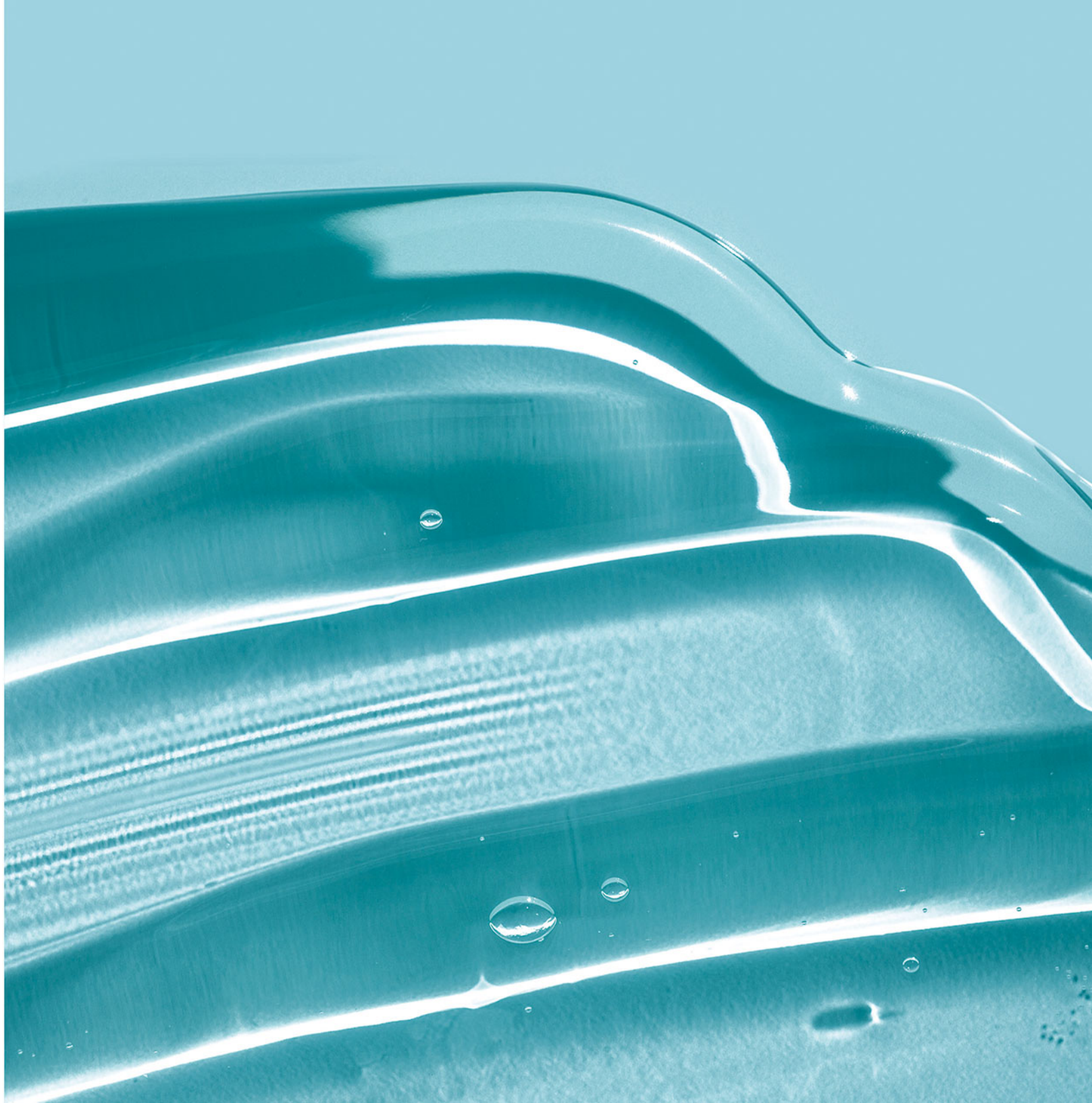
